State-specific requirements:

Florida: The statement must be conspicuous and in capital letters. The statement must also be “conspicuously displayed **on any webpage** that identifies a mailing address where contributions are to be sent, identifies a telephone number to call to process contributions, or provides for online processing of contributions.” (Emphasis added.)

New Jersey: The statement must be conspicuous and in capital letters.

New York: The statement must be in at least 10-point type, bold face.

North Carolina: The statement must be in at least 9-point type, and either be underlined, be in bold type, or be in a box.

Pennsylvania: The statement must be conspicuous.

West Virginia: The statement must be conspicuous. If a solicitation package contains multiple pieces, the statement must be “on a prominent part of the solicitation materials.”
